PUBLIC PARTICIPATION (PUBLIC COMMENT)

If you wish to speak, complete a Speaker's Card for each item and submit to the City Clerk before the public comment period of the item. Public testimony is limited to three (3) minutes per speaker and a speaker's time may not be transferred to another speaker. Written comments submitted by individuals at the meeting may not be read aloud by another speaker nor will be read aloud by the City.

Option B: To submit written public comments prior to the meeting

Members of the public may submit written comments **on the Closed Session item(s) only** **by sending an email to: comments@agourahillscity.gov. All public correspondence received by 1:00 pm on the meeting date will be provided to the City Council prior to the meeting.** Public comments are not read into the record by the City. Any comments submitted after the deadline may not be considered as part of the City Council's deliberations or included in the official record. However, the public may attend the meeting to make or submit written comments in person.
