**BACKGROUND:**

Section 7.08 of the Allen City Charter states: "Returns of all municipal elections, both general and special, shall be made in accordance with the Texas Election Code, at which time the council shall canvass the votes, declare the results of such election, with notification of election to the candidate elected." and Section 67.003 of the Texas Election Code states: "Each local canvassing authority shall convene to conduct the local canvass at the time set by the canvassing authority's presiding officer not earlier than the eighth day or later than the 11th day after Election Day." The Early Voting Ballot Board will reconvene on May 11 to count returned military overseas ballots (FPCA - Federal Post Card Application) and provisional ballots at which time the Election Administrator will issue the final vote tallies to be canvassed by the Allen City Council at this meeting. A copy of the unofficial election results released on Election Day are attached.

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ALLEN, COLLIN COUNTY, TEXAS, DECLARING THE RESULTS OF THE JOINT GENERAL ELECTION OF THE CITY OF ALLEN HELD MAY 2, 2026, FOR THE PURPOSE OF ELECTING THE MAYOR AND CITY COUNCILMEMBER FOR PLACE NO. 2; AND PROVIDING AN EFFECTIVE DATE.**

**WHEREAS**, it is hereby found and determined that notice of the election was duly given in the form, manner and time required by law, and said election was in all respects legally held and conducted in accordance with applicable laws of the State of Texas and the proceedings calling and governing the holding of such election; and,
