RECOMMENDATION:

It is recommended that the Public Safety Commission receive and file this quarterly update on Southwest Patrol activities.

BACKGROUND:

In July 2025, the City entered into a contract agreement with Southwest Patrol, a private security company, to provide unarmed supplemental patrol services throughout the community. The partnership enhances public safety presence, helps deter nuisance activity, and supports City staff in addressing quality-of-life issues. As committed to the City Council, Staff provides quarterly updates to the Public Safety Commission summarizing activity and trends.

ANALYSIS:

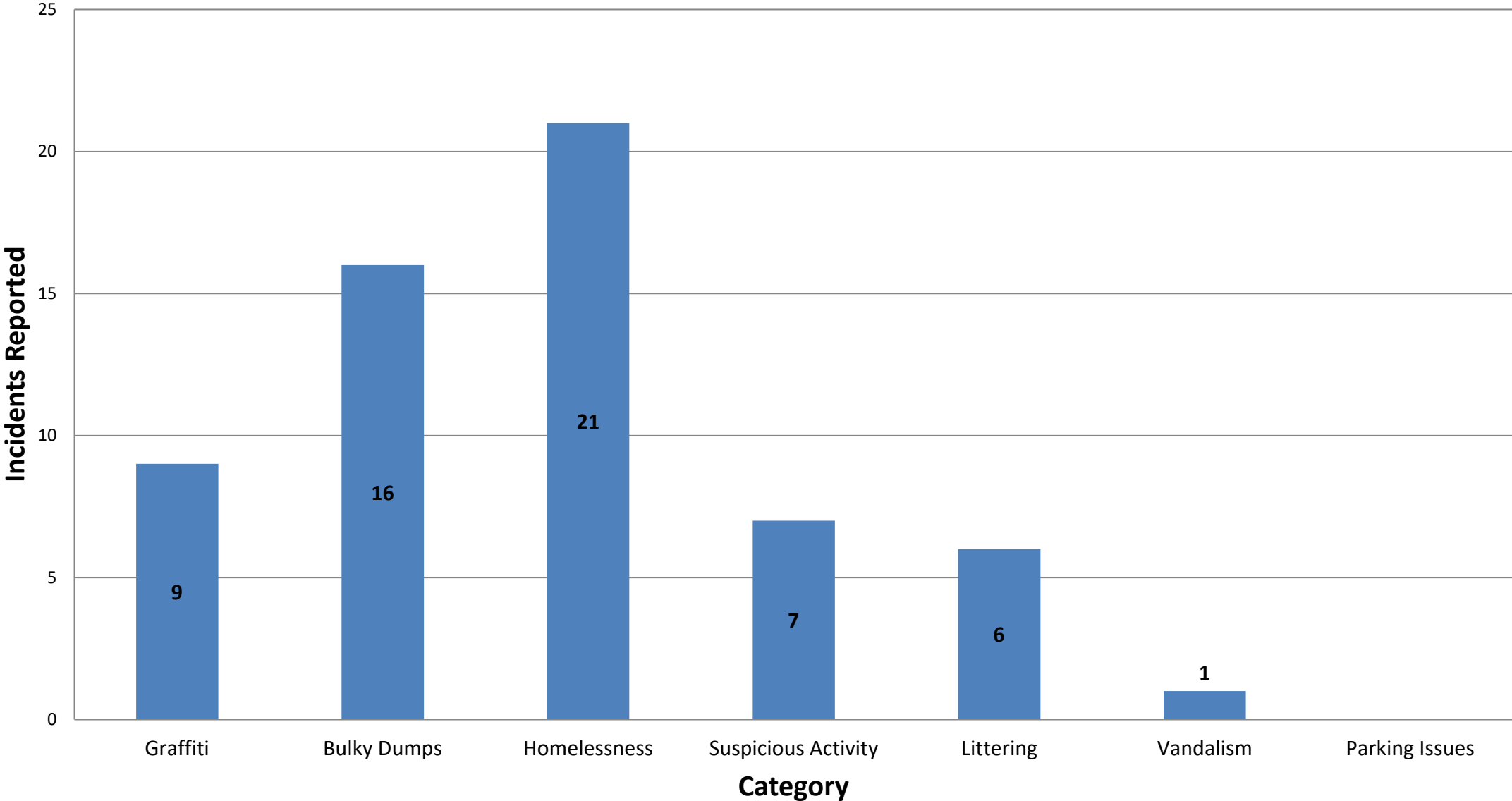
Between October 15, 2025 and January 2, 2026, Southwest Patrol reported a total of 60 documented incidents. The most frequent reports included homeless-related activity (21) and illegal bulky dumping items (16), followed by Graffiti (9), Suspicious Activity (7), Littering (6), and Vandalism (1).

The data reflects Southwest Patrol's continued responsiveness in reporting public safety issues to City staff on a daily basis. Once City staff receives issues indicated in reports, they are triaged to the appropriate internal City department for correction. Staff continues to coordinate with the Code Compliance and Public Works Departments to ensure that incidents identified through patrol reports are resolved promptly and effectively. If Southwest Patrol detect any serious crimes, they are trained to contact the Los Angeles County Sheriff's Lakewood Station directly and subsequently provide a report to the City.

SUBJECT: Community Partnership Program for License Plate Reader Cameras

RECOMMENDATION:

Staff recommends that the Public Safety Commission discuss the two programs and provide a recommendation to be presented to the City Council Public Safety Committee for consideration.

BACKGROUND:

At its October 23, 2025 special meeting, the Public Safety Commission received a staff report regarding the potential implementation of a Community Partnership Program for Automated License Plate Reader (ALPR) cameras. At that meeting, staff indicated that additional information would be gathered on two potential programs: the Flock Safety Community Partnership Program and a similar, still-developing community partnership concept offered by Motorola Solutions (Vigilant).

The Commission requested that staff further evaluate both options and report back any findings to better understand functionality, compatibility with the City's existing ALPR infrastructure, the maturity of each program, and potential impacts to law enforcement operations.

ANALYSIS:

Flock Safety Community Partnership Program

The Flock Safety Community Partnership Program is an established program currently utilized by multiple cities and allows residents, neighborhood groups, and homeowner associations to purchase and install Flock ALPR cameras within their communities. Privately owned cameras may be integrated into a municipal Flock network, allowing law enforcement agencies access to relevant data during criminal investigations and public safety incidents.

This program is currently utilized by the City of Lakewood and is designed to expand neighborhood-level security while leveraging private investment in public safety infrastructure. However, Artesia is not currently a Flock customer. Participation in the Flock program would require Sheriff's deputies to operate within a separate ALPR system from the City's existing platform, potentially resulting in reduced operational efficiency, redundant workflows, and additional training requirements. Sheriff personnel has also shared with city staff that a key inconvenience within Flock is that data is only saved for approximately one (1) month and then is automatically removed from the system.

Motorola Solutions (Vigilant) Community Partnership

The City of Artesia currently utilizes fifteen (15) Vigilant ALPR cameras provided by Motorola Solutions. Based on information received from Motorola, the company is in the early stages of developing a community-based ALPR offering that would allow homeowner associations, neighborhood groups, and private businesses to purchase Motorola L6Q cameras capable of integrating into an existing Vigilant/Motorola network.

While this program is not yet as formalized or widely implemented as the Flock Safety Community Partnership Program, Motorola has indicated that its intent is to allow vehicle data captured by privately owned cameras to be shared with law enforcement, thereby enhancing investigative capabilities while maintaining a single, unified ALPR platform.

Motorola has indicated that pricing for community purchased cameras would start at approximately \$2,875.20 annually. As the program continues to develop, this approach may provide an opportunity for Artesia to expand ALPR coverage in residential areas without requiring deputies to operate within multiple systems.

FISCAL IMPACT:

The cost of the cameras would be funded entirely by homeowner associations, neighborhood groups and private businesses and there would be not cost to the City for the purchase or use of the cameras. Implementation of either program would require incidental impacts to the general fund regarding staff coordination time and community outreach to advertise a program.
