The Los Angeles County Registrar-Recorder/County Clerk has canvassed and certified the returns of the City's General Municipal Election held on June 2, 2026. Set forth and attached to Resolution No. 6743 are the total numbers of votes cast for each candidate at each precinct, all of which is contained within "Exhibit A", and the total numbers of votes cast for Measure GG, all of which is contained within Exhibit "B"; and the Certificate of Canvass of the Election Returns are presented herewith for your approval and adoption.

The City's June 2, 2026 General Election included an overall voter turnout of 35.44%.

RESOLUTION NO. 6743

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF
GARDENA, CALIFORNIA, RECITING THE FACT OF THE
GENERAL MUNICIPAL ELECTION HELD ON JUNE 2, 2026,
DECLARING THE RESULT AND SUCH OTHER MATTERS
AS PROVIDED BY LAW**

WHEREAS, a General Municipal Election was held in the City of Gardena, California, on Tuesday, June 2, 2026, and conducted by the Los Angeles Registrar-Recorder as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California for the holding of elections in general law cities; and

WHEREAS, the Los Angeles County Registrar-Recorder/County Clerk canvassed the returns of the election and has certified the results to this City Council, the results are received, attached and made a part hereof as "Exhibit A" and "Exhibit B".

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF GARDENA, CALIFORNIA, DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. That the whole number of ballots cast in the precincts (including provisional), except vote by mail ballots, was 2,298; and

That the whole number of votes by mail cast in the City was 10,871, making a total of 13,169 ballots cast in the City.

SECTION 2. That the names of persons voted for Mayor of the City Council are as follows:

SECTION 3. That the Measure voted on is the City of Gardena's Transactions and Use Tax (Local Sales Tax) Measure; which would maintain fire, paramedic, police, 911 response; hiring and retaining well-trained police helping prevent property crimes; keep public areas/parks safe/clean; addressing homelessness; repairing streets and potholes; maintaining afterschool programs and senior services; by establishing a ¼¢ sales tax, providing approximately \$3,900,000 annually until ended by voters, requiring audits, public spending disclosure, all fund controlled locally.

SECTION 4. That the number of votes given at each precinct and the number of votes given in the City to each of the persons above named for the respective offices for which the persons were candidates were as listed in "Exhibit A", and the number of votes given to each precinct and the number of votes given in the City to Measure were as listed in "Exhibit B" attached.

SECTION 5. That the City Council does declare and determine that: TASHA CERDA was elected as Mayor for the full term of four (4) years; RODNEY G. TANAKA was elected as Member of the City Council for the full term of four (4) years; JEFF FUKASAWA was elected as Member of the City Council for the full term of four

(4) years; BECKY ROMERO was elected as City Clerk for the full term of four (4) years; and KALE MORITA was elected as City Treasurer for the full term of four (4) years.

SECTION 6. That the City Council declares and determines that: Measure GG has passed by the following vote: 7,830 voted YES, and 4,241 voted NO.

SECTION 7. That the City Clerk shall enter on the records of the City Council of the City, a statement of the result of the election, showing: (1) The whole number of ballots cast in the City for the Council Member positions; (2) The names of the persons voted for; (3) For what office each person was voted for; (4) The number of votes given at each precinct to each person; and (5) The total number of votes given to each person.

SECTION 8. That the City Clerk shall enter on the records of the City Council of the City, a statement of the result of the election, showing: (1) The whole number of ballots cast in the City for the measure; and (2) The number of votes given at each precinct; and (3) The total number of votes given towards the measure.

SECTION 9. That the City Clerk shall immediately make and deliver to each of the persons so elected a Certificate of Election signed by the City Clerk and authenticated; that the City Clerk shall also administer to each person elected the Oath of Office prescribed in the Constitution of the State of California and shall have them subscribe to it and file it in the office of the City Clerk. Each and all of the persons so elected shall then be inducted into the respective office to which they have been elected.

SECTION 10. BE IT FURTHER RESOLVED that the City Clerk shall certify to the passage and adoption of this Resolution; shall cause the same to be entered among the original Resolutions of said City; and shall make a minute of the passage and adoption thereof in the records of the proceedings of the City Council of said City in the minutes of the meeting at which the same is passed and adopted.
